The only announcements that will be considered are **Ready for Trial, Ready Non-Jury, or Not Ready for Trial**. If **Not Ready for Trial**, briefly state the reason the case is not ready. If you announce **Ready for Trial**, please confirm whether or not there are any outstanding pretrial motions in your case. If all parties announce Ready for Trial and there are no outstanding pretrial motions, the Court will place your case on the next available trial calendar. If you announce **Ready Non-Jury**, all attorneys/parties must file a Waiver of Jury Trial in order for the case to be scheduled for a final hearing. A **Conflict Letter or Leave of Absence** does not relieve you from making a written announcement.

A case in which no written announcement has been made and in which no one appears at the Calendar Call to make an announcement will be noticed to appear in person on an upcoming motion day.

To advise the status of your case in writing, **email your announcement to Judge Petty** (or fax if email is not available) and **Efile the original announcement** to the Clerk. When identifying your case, please refer to the page and item number listed on the calendar.
