Pursuant to USCR 20, all attorneys and pro se litigants are required to appear at the Calendar Call on July 22, 2024, or make written announcement, which must be received by the Judge's Office and the Clerk's Office by 12:00 p.m. on July 17, 2024, the Wednesday BEFORE the day of calendar call.

The only announcements that will be considered are Ready for Trial, Ready Non-Jury, or Not Ready for Trial. If Not Ready for Trial, briefly state the reason the case is not ready, your grounds for seeking a continuance, and whether or not the opposing parties have agreed to a continuance. All continuances must be approved by Judge Massey. If you announce Ready Non-Jury, all attorneys/parties must file a Waiver of Jury Trial in order for the case to be placed on the Non-jury calendar. A Conflict Letter or Leave of Absence does not relieve you from making a written announcement.

A case in which no written announcement has been made and in which no one appears at the Calendar Call to make an announcement will either be marked **Ready for Trial** or the Judge may enter an Order of Dismissal Without Prejudice of plaintiff's action or defendant's answer, counterclaim or crossclaim. If you attend the Calendar Call, please bring your calendar to court as copies will not be available that morning.

To advise the status of your case in writing, email your announcement to Judge Massey (or fax if email is not available) and Efile the original announcement with the Clerk. When identifying your case, please refer to the page and item number listed on the calendar.
